




Non-Oil Foreign Trade

Non-Oil Foreign Trade reaches 676 Billion AED in First half 2019.


Foreign Trade by Type

- Foreign Trade Imports amounted 390,462
 Million AED in First Half 2019, with contribution of 57.7%.
- Foreign Trade Exports amounted 76,367
 Million AED in First Half 2019, with contribution of 11.3%.
- Foreign Trade Re-Exports amounted 209,461 Million AED in First Half 2019, with contribution of 31.0%.



Foreign Trade by Zone

- Direct Foreign Trade amounted 385,484
 Million AED in First Half 2019, with contribution of 57.0%.
- Free Zone Trade amounted 286,772 Million AED in First Half 2019, with contribution of 42.4%.
- Custom Warehouse Trade amounted 4,033 Million AED in First Half 2019, with contribution of 0.6%.









Direct Foreign Trade


- Direct Foreign Trade Imports amounted 240,205 Million AED in First Half 2019, with contribution of 62.3%.
- Direct Foreign Trade Exports amounted 60,846 Million AED in First Half 2019, with contribution of 15.8%.
- Direct Foreign Trade Re-Exports amounted 84,433 Million AED in First Half 2019, with contribution of 21.9%
- In First Half 2019, Pearls, precious stones and metals obtain the lead in Imports with amount of 84,534 Million AED and contribution of 35.2%, then Machinery, sound recorders, tv and electrical equipment amounted to 40,592 Million AED with contribution of 16.9%, followed by Vehicles, aircraft and vessels amounted to 18,364 Million AED with contribution of 7.6%.
- In First Half 2019, Pearls, precious stones and metals obtain the lead in Exports with amount of 28,304 Million AED and contribution of 46.5%, then Base metals and articles of base metals amounted to 13,703 Million AED with contribution of 22.5%, followed by Products of chemical and allied industries amounted to 3,768 Million AED with contribution of 6.2%.
- In First Half 2019, Pearls, precious stones and metals obtain the lead in Re-Export with amount of 37,238 Million AED and contribution of 44.1%, then Machinery, sound recorders, tv and electrical equipment amounted to 15,282 Million AED with contribution of 18.1%, followed by Vehicles, aircraft and vessels amounted to 14,262 Million AED with contribution of 16.9%.




The most outstanding sections in Direct Foreign Trade Imports (value in Million)








Free Zone Trade

- Imports amounted to 147,075 Million AED and contributed 51.3% of Free Zone Trade in First Half 2019.
- Exports amounted to 14,669 Million AED and contributed 5.1% of Free Zone Trade in First Half 2019.
- Re-Exports amounted to 125,028 Million AED and contributed 43.6% of Free Zone Trade in First Half 2019.
- In First Half 2019, Machinery, sound recorders, tv and electrical equipment obtain the lead in Imports of Free Zone Trade with amount of 61,801 Million AED and contribution of 42.0%, then Mineral products amounted to 20,356 Million AED with contribution of 13.8%, followed by Pearls, precious stones and metals amounted to 17,581 Million AED and contribution of 12.0%.
- In First Half 2019, Mineral products obtain the lead in Exports of Free Zone Trade with amount of 6,996 Million AED and contribution of 47.7%, then Prepared foodstuffs amounted to 3,113 Million AED with contribution of 21.2%, followed by Machinery, sound recorders, tv and electrical equipment amounted to 1,954 Million AED and contribution of 13.3%.
- In First Half 2019, Machinery, sound recorders,tv and electrical equipment obtain the lead in Re-Export of Free Zone Trade with amount of 66,492 Million AED and contribution of 53.2%, then Pearls, precious stones and metals amounted to 14,958 Million AED with contribution of 12.0%, followed by Mineral products amounted to 9,219 Million AED and contribution of 7.4%.








The most outstanding sections in Free Zone Trade Exports (value in Million)



The most outstanding sections in Free Zone Trade Re-Exports (value in Million)









Custom Warehouse Trade

- Imports amounted to 3,182 Million AED and contributed 78.9% of Custom Warehouse Trade in First Half 2019.
- Exports amounted to 852 Million AED and contributed 21.1% of Custom Warehouse Trade in First Half 2019.
- In First Half 2019, Vehicles, aircraft and vessels obtain the lead in Imports of Custom Warehouse Trade with amount of 2,415 Million AED and contribution of 75.9%, then Machinery, sound recorders, tv and electrical equipment amounted to 515 Million AED with contribution of 16.2%, followed by Optical, medical equipments and watches amounted to 78 Million AED and contribution of 2.5%.
- In First Half 2019, Machinery, sound recorders, tv and electrical equipment obtain the lead in Exports of Custom Warehouse Trade with amount of 423 Million AED and contribution of 49.7%, then Vehicles, aircraft and vessels amounted to 310 Million AED with contribution of 36.4%, followed by Optical, medical equipments and watches amounted to 51 Million AED and contribution of 6.0%.
