


Producer Price Index "Manufacturing Sector"

2019

Producer price index for manufacturing sector during the 2019 reached 100.23, recording a decrease of 4.38% compared to 2018, which recorded 104.82.

The drop in the producer prices for manufactured products was particularly attributable to fallen prices of Refined petroleum products by 8.92%, basic metals by 8.89%, beverages by 4.73%, rubber and plastics products by 4.45%, fabricated metal products, except machinery and equipment by 3.90%, motor vehicles, trailers and semi-trailers by 3.85%, leather and related products by 1.73%, tobacco products by 1.57%, of repair and installation of machinery and equipment by 1.39%, food products decrease by 1.36%, furniture by 1.07%, wood and products of wood and cork, except furniture by 0.69%, electrical equipment by 0.51%, other non-metallic mineral products by 0.48%, printing and reproduction of recorded media by 0.38%.

On the other hand, some industries recorded an increase in their prices during 2019 compared to 2018. as the prices of other manufacturing industries increased by 9.54%, machinery and equipment n.e.c. by 2.16%, chemicals and chemical products by 0.87%, textiles by 0.42% and paper and paper products by 0.38%.

While stability observed in prices of wearing apparel, basic pharmaceutical products, pharmaceutical preparations, and other transport equipment during 2019 compared to 2018.
