




# Non-Oil Foreign Trade

Non-Oil Foreign Trade reaches 1 Trillion and 302 Billion AED in 2017


## Foreign Trade by Type

- Foreign Trade Imports amounted 798,309 Million AED in 2017, with contribution of 61.3%.
- Foreign Trade Exports amounted 143,756 Million AED in 2017, with contribution of 11.0%.
- Foreign Trade Re-Exports amounted 359,726 Million AED in 2017, with contribution of 27.6%.



## Foreign Trade by Zone

- Direct Foreign Trade amounted 828,692 Million AED in 2017, with contribution of 63.7%.
- Free Zone Trade amounted 433,902 Million AED in 2017, with contribution of 33.3%.
- Custom Warehouse Trade amounted 39,196 Million AED in 2017, with contribution of 3.0%.









### **Direct Foreign Trade**


- Direct Foreign Trade Imports amounted 518,279
  Million AED in 2017, with contribution of 62.5%.
- Direct Foreign Trade Exports amounted 123,661
  Million AED in 2017, with contribution of 14.9%
- Direct Foreign Trade Re-Exports amounted 186,752 Million AED in 2017, with contribution of 22.5%.
- In 2017, Pearls, precious stones and metals obtain the lead in Imports with amount of 178,164 Million AED and contribution of 34.4%, then Machinery, sound recorders, TV and electrical equipment amounted to 107,071 Million AED with contribution of 20.7%, followed by Vehicles, aircraft and vessels amounted to 57,298 Million AED with contribution of 11.1%.
- In 2017, Pearls, precious stones and metals obtain the lead in Exports with amount of 63,778 Million AED and contribution of 51.6%, then Base metals and articles of base metals amounted to 24,517 Million AED with contribution of 19.8%, followed by Prepared foodstuffs amounted to 8,735 Million AED with contribution of 7.1%.
- In 2017, Pearls, precious stones and metals obtain the lead in Re-Export with amount of 73,169 Million AED and contribution of 39.2% then Machinery, sound recorders, TV and electrical equipment amounted to 42,211 Million AED with contribution of 22.6%, followed by Vehicles, aircraft and vessels amounted to 35,359 Million AED with contribution of 18.9%.




The most outstanding sections in Direct Foreign Trade Imports (value in Million)







The most outstanding sections in Direct Foreign Trade Re-Exports (value in Million)










#### Free Zone Trade

- Imports amounted to 245,689 Million AED and contributed 56.6% of Free Zone Trade in 2017.
- Exports amounted to 15,239 Million AED and contributed 3.5% of Free Zone Trade in 2017.
- Re-Exports amounted to 172,974 Million AED and contributed 39.9% of Free Zone Trade in 2017.
- In 2017, Machinery, sound recorders, TV and electrical equipment obtain the lead in Imports of Free Zone Trade with amount of 120,784 Million AED and contribution of 49.2%, then Mineral products amounted to 19,448 Million AED with contribution of 7.9%, followed by Vehicles, aircraft and vessels amounted to 18,827 Million AED and contribution of 7.7%.
- In 2017, Prepared foodstuffs obtain the lead in Exports of Free Zone Trade with amount of 4,590 Million AED and contribution of 30.1%, then Machinery, sound recorders, TV and electrical equipment amounted to 3,184 Million AED with contribution of 20.9%, followed by Vehicles, aircraft and vessels amounted to 1,826 Million AED and contribution of 12.0%.
- In 2017, Machinery, sound recorders, TV and electrical equipment obtain the lead in Re-Export of Free Zone Trade with amount of 95,685 Million AED and contribution of 55.3%, then Vehicles, aircraft and vessels amounted to 12,770 Million AED with contribution of 7.4%, followed by Mineral products amounted to 12,224 Million AED and contribution of 7.1%.





The most outstanding sections in Free Zone Trade Imports (value in Million)





The most outstanding sections in Free Zone Trade Exports (value in Million)











### **Custom Warehouse Trade**

- Imports amounted to 34,341 Million AED and contributed 87.6% of Custom Warehouse Trade in 2017.
- Exports amounted to 4,855 Million AED and contributed 12.4% of Custom Warehouse Trade in 2017.
- In 2017, Machinery, sound recorders, TV and electrical equipment obtain the lead in Imports of Custom Warehouse Trade with amount of 25,740 Million AED and contribution of 75.0%, then Vehicles, aircraft and vessels amounted to 7,163 Million AED with contribution of 20.9%, followed by Prepared foodstuffs amounted to 544 Million AED and contribution of 1.6%.
- In 2017, Machinery, sound recorders, TV and electrical equipment with amount of 2,989 Million AED and contribution of 61.6%, then Vehicles, aircraft and vessels amounted to 1,023 Million AED with contribution of 21.1%, followed Prepared foodstuffs amounted to 511 Million AED and contribution of 10.5%.
