

Non-Oil Foreign Trade reaches 1.02 Trillion AED Till Third Quarter 2019


1.1 Foreign Trade by Type

- Foreign Trade Imports amounted 589,008 Million AED Till Third Quarter 2019, with contribution of 57.8%.
- Foreign Trade Exports amounted 118,537 Million AED Till Third Quarter 2019, with contribution of 11.6%.
- Foreign Trade Re-Exports amounted 311,855 Million AED Till Third Quarter 2019, with contribution of 30.6%.



1.2 Foreign Trade by Zone

- Direct Foreign Trade amounted 573,709 Million AED Till Third Quarter 2019, with contribution of 56.3%.
- Free Zone Trade amounted 439,398 Million AED Till Third Quarter 2019, with contribution of 43.1%.
- Custom Warehouse Trade amounted 6,293 Million AED Till Third Quarter 2019, with contribution of 0.6%.





1.3 Direct Foreign Trade

- Direct Foreign Trade Imports amounted 356,461 Million AED Till Third Quarter 2019, with contribution of 62.1%.
- Direct Foreign Trade Exports amounted 95,896 Million AED Till Third Quarter 2019, with contribution of 16.7%.
- Direct Foreign Trade Re-Exports amounted 121,352
 Million AED Till Third Quarter 2019, with contribution of 21.2%.

1.3.1 Direct Foreign Trade Imports

 Till Third Quarter 2019, Pearls, precious stones and metals obtain the lead in Imports with amount of 128,689 Million AED and contribution of 36.1%, then Machinery, sound recorders, tv and electrical equipment amounted to 61,479 Million AED with contribution of 17.2%, followed by Vehicles, aircraft and vessels amounted to 27,977 Million AED with contribution of 7.8%.


1.3.2 Direct Foreign Trade Exports

 Till Third Quarter 2019, Pearls, precious stones and metals obtain the lead in Exports with amount of 47,088 Million AED and contribution of 49.1%, then Base metals and articles of base metals amounted to 19,926 Million AED with contribution of 20.8%, followed by Products of chemical and allied industries amounted to 5,775 Million AED with contribution of 6.0%.


1.3.3 Direct Foreign Trade Re-Exports

 Till Third Quarter 2019, Pearls, precious stones and metals obtain the lead in Re-Export with amount of 51,612 Million AED and contribution of 42.5%, then Machinery, sound recorders, tv and electrical equipment amounted to 23,135 Million AED with contribution of 19.1%, followed by Vehicles, aircraft and vessels amounted to 20,814 Million AED with contribution of 17.2%.






The most outstanding sections in Direct Foreign Trade Exports (value in Million)

1.4 Free Zone Trade

- Imports amounted to 227,761 Million AED and contributed 51.8% of Free Zone Trade Till Third Quarter 2019.
- Exports amounted to 21,134 Million AED and contributed
 4.8% of Free Zone Trade Till Third Quarter 2019.
- Re-Exports amounted to 190,502 Million AED and contributed 43.4% of Free Zone Trade Till Third Quarter 2019.

1.4.1 Free Zone Trade Imports

 Till Third Quarter 2019, Machinery, sound recorders, tv and electrical equipment obtain the lead in Imports of Free Zone Trade with amount of 94,421 Million AED and contribution of 41.5%, then Mineral products amounted to 33,054 Million AED with contribution of 14.5%, followed by Pearls, precious stones and metals amounted to 28,284 Million AED and contribution of 12.4%.


1.4.2 Free Zone Trade Exports


 Till Third Quarter 2019, Mineral products obtain the lead in Exports of Free Zone Trade with amount of 9,295 Million AED and contribution of 44.0%, then Prepared foodstuffs amounted to 4,550 Million AED with contribution of 21.5%, followed by Machinery, sound recorders, tv and electrical equipment amounted to 3,319 Million AED and contribution of 15.7%.

1.4.3 Free Zone Trade Re-Exports

 Till Third Quarter 2019, Machinery, sound recorders, tv and electrical equipment obtain the lead in Re-Export of Free Zone Trade with amount of 99,609 Million AED and contribution of 52.3%, then Pearls, precious stones and metals amounted to 23,772 Million AED with contribution of 12.5%, followed by Mineral products amounted to 14,803 Million AED and contribution of 7.8%.

- Exports amounted to 1,506 Million AED and contributed 23.9% of Custom Warehouse Trade Till Third Quarter 2019.


1.5.1 Custom Warehouse Trade Imports


 Till Third Quarter 2019, Vehicles, aircraft and vessels obtain the lead in Imports of Custom Warehouse Trade with amount of 3,753 Million AED and contribution of 78.4%, then Machinery, sound recorders, tv and electrical equipment amounted to 695 Million AED with contribution of 14.5%, followed by Optical, medical equipments and watches amounted to 109 Million AED and contribution of 2.3%.

1.5.2 Custom Warehouse Trade Exports

Till Third Quarter 2019, Vehicles, aircraft and vessels obtain the lead in Exports of Custom Warehouse Trade with amount of 803 Million AED and contribution of 53.3%, then Machinery, sound recorders, tv and electrical equipment amounted to 539 Million AED with contribution of 35.8%, followed by Optical, medical equipments and watches amounted to 74 Million AED and contribution of 4.9%.
