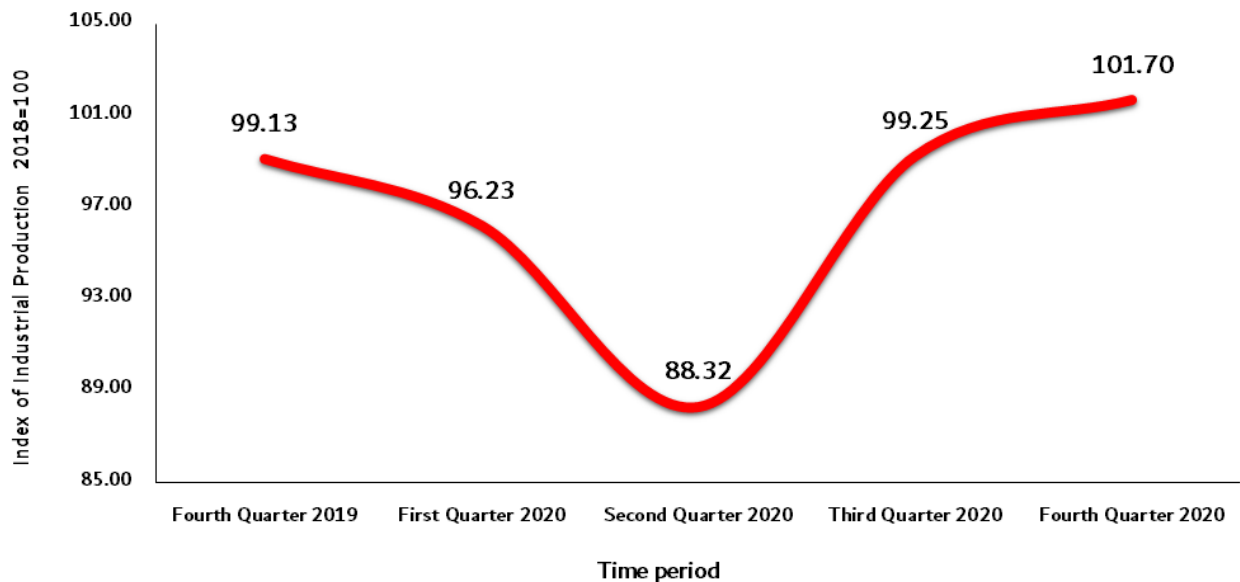
| Index of Industrial Production "Manufacturing Sector"

Fourth Quarter 2020 – Emirates of Dubai

The index of industrial production for the manufacturing sector for the fourth quarter of 2020 recorded an increase of 2.47% compared to the third quarter of 2020 and increase of 2.59% compared to the fourth quarter of 2019.

| Movement of Industrial Production Index for manufacturing sector during Fourth Quarter 2020 compared to Third Quarter 2020 (Quarterly change)

The index of industrial production for the manufacturing sector during the fourth quarter of 2020 recorded an increase of 2.47% compared to the third quarter of 2020. This increment is due to an increase in the production of other manufacturing industries by 57.83%, fabricated metal products, except machinery and equipment by 23.13%, furniture by 21.23%, Motor vehicles, trailers and semi-trailers by 16.35%, rubber and plastics products by 13.24%, other non-metallic mineral products by 9.98%, wood, wood products and cork, except furniture by 8.83%, machinery and equipment n.e.c by 8.64%, electrical equipment by 7.79%, tobacco products by 7.00%, repair and installation of machines and equipment by 3.17%, basic metals by 2.81%, refined petroleum products by 2.54%, food products by 1.17%.

On the other hand, some industries recorded a decrease in their production compared to the third quarter of 2020, as the production of wearing apparel decreased by 47.05%, leather and related products decreased by 28.37%, Textiles by 25.32%, basic pharmaceutical products and pharmaceutical preparations by 17.32%, beverages by 15.65%, printing and reproduction of recorded media by 7.12%, chemicals and chemical products by 2.19% and paper and paper products by 0.09%.

While other transport equipment maintained its stability for the fourth quarter of 2020 compared to third quarter 2020.

| Movement of Industrial Production Index for manufacturing sector during Fourth Quarter 2020 compared to Fourth Quarter 2019 (Annual change)

The index of industrial production for the manufacturing sector during the fourth quarter of 2020-recorded an increase by 2.59% compared to the fourth quarter of 2019. This increment is due to an increase in the production of Wearing apparel by 69.50%, other manufacturing industries by 68.38%, food products by 29.34%, electrical equipment by 27.43%, Wood and products of wood and cork, except furniture by 25.43%, Fabricated metal products, except machinery and equipment by 18.04%, basic pharmaceutical products and pharmaceutical preparations by 11.67%, Basic metals by 7.64%, refined petroleum products by 1.73%, rubber and plastics products by 1.14%,Furniture by 0.70% .

On the other hand, some industries recorded a decrease in their production compared to the fourth quarter of 2019, as the production of chemicals and chemical products decreased by 34.53%, other transport equipment by 22.22%, motor vehicles, trailers and semi-trailers by 19.33%, printing and reproduction of recorded media by 16.34%, tobacco products by 16.11%, repair and installation of machinery and equipment by 15.15%, paper and paper products by 10.20%, Beverages by 8.76%, leather and related products by 7.74%, machinery and equipment n.e.c by 2.35%, other non-metallic mineral products by 1.27%, and textiles by 0.32%.
