


Producer Price Index "Manufacturing Sector"

Dubai - 2020

Producer price index for manufacturing sector during the 2020 reached 95.86, recording a decrease of 4.36% compared to 2019, which recorded 100.23.

Producer Price "Manufacturing sector" movement during 2020 compared to the 2019

Producer price index for manufacturing sector recorded a decrease by 4.36% during 2020 compared to the year of 2019.

The drop in the producer prices for manufactured products was particularly attributable to fallen prices of Refined petroleum products by 31.42%, basic metals by 6.79%, rubber and plastics products by 5.67%, leather and related products by 4.95%, motor vehicles, trailers and semi-trailers by 4.63 %, machinery and equipment n.e.c. by 3.97%, basic pharmaceutical products, pharmaceutical preparations by 3.83%, other non-metallic mineral products by 2.54%, textiles by 1.68%, electrical equipment by 0.64%, furniture by 0.34%, repair and installation of machinery and equipment by 015%, tobacco products by 0.01%,

On the other hand, some industries recorded an increase in their prices during 2020 compared to 2019. as the prices of other manufacturing industries increased by 26.11%, printing and reproduction of recorded media by 9.82%, chemicals and chemical products by 6.26%, food products decrease by 1.38%, paper and paper products by 0.49%, fabricated metal products, except machinery and equipment by 0.32%, beverages by 0.28%.

While stability observed in prices of wearing apparel, wood and products of wood and cork, except furniture and other transport equipment during 2020 compared to 2019.
