

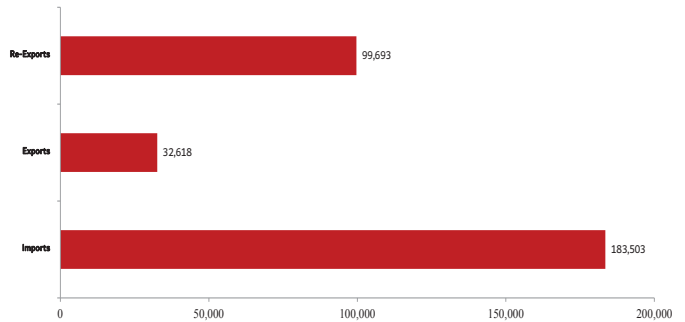

Non-Oil Foreign Trade reaches 316 Billion AED in Quarter One 2018

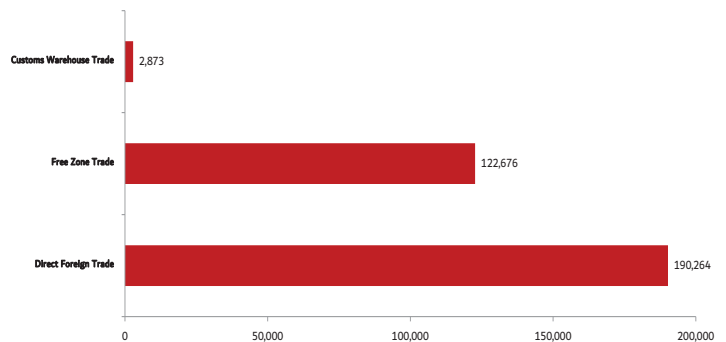
Foreign Trade by Type

- Foreign Trade Imports amounted 183,503 Million AED in Quarter One 2018, with contribution of 58.1%.
- Foreign Trade Exports amounted 32,618 Million AED in Quarter One 2018, with contribution of 10.3%.
- Foreign Trade Re-Exports amounted 99,693 Million AED in Quarter One 2018, with contribution of 31.6%.



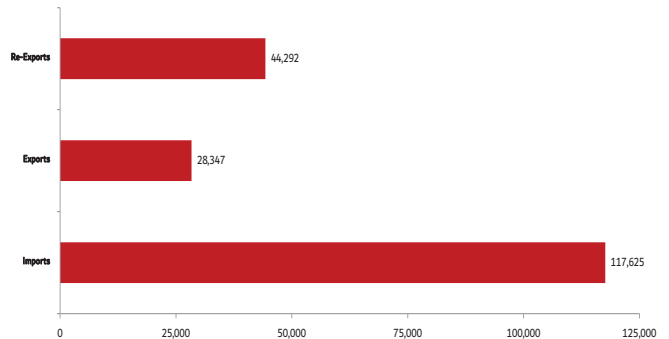
Foreign Trade by Zone

- Direct Foreign Trade amounted 190,264 Million AED in Quarter One 2018, with contribution of 60.2%.
- Free Zone Trade amounted 122,676 Million AED in Quarter One 2018, with contribution of 38.8%.
- Custom Warehouse Trade amounted 2,873 Million AED in Quarter One 2018, with contribution of 0.9%.



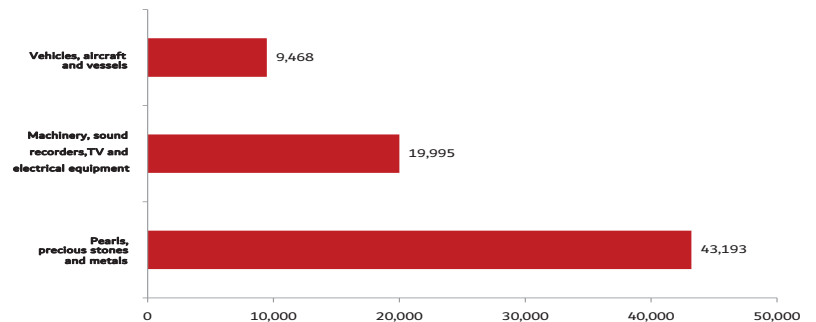
Direct Foreign Trade

- Direct Foreign Trade Imports amounted 117,625 Million AED in Quarter One 2018, with contribution of 61.8%.
- Direct Foreign Trade Exports amounted 28,347 Million AED in Quarter One 2018, with contribution of 14.9%
- Direct Foreign Trade Re-Exports amounted 44,292 Million AED in Quarter One 2018, with contribution of 23.3%.



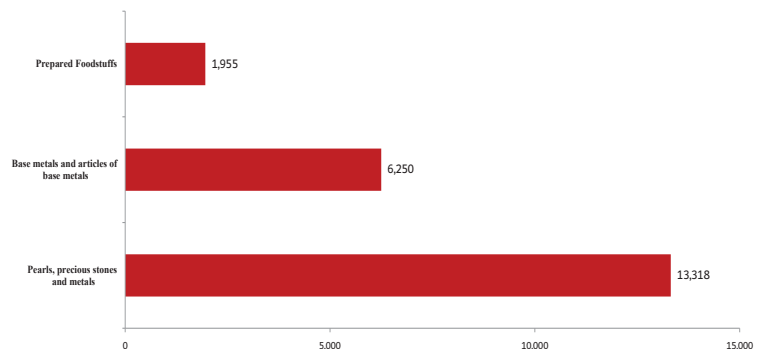
- In Quarter One 2018, Pearls, precious stones and metals obtain the lead in Imports with amount of 43,193 Million AED and contribution of 36.7%, then Machinery, sound recorders, TV and electrical equipment amounted to 19,995 Million AED with contribution of 17.0%, followed by Vehicles, aircraft and vessels amounted to 9,468 Million AED with contribution of 8.0%.

The most outstanding sections in Direct Foreign Trade Imports (value in Million)



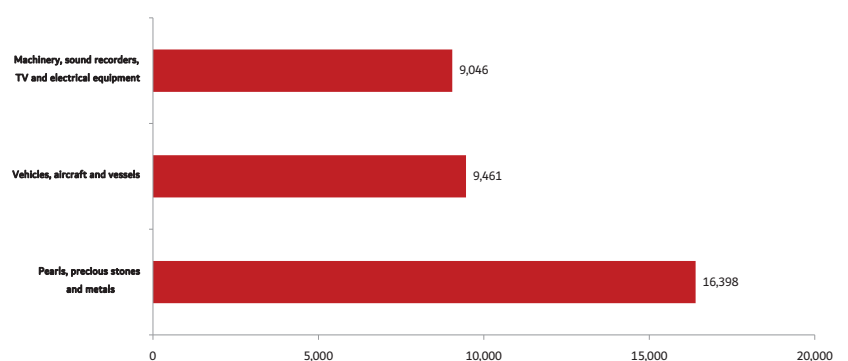
- In Quarter One 2018, Pearls, precious stones and metals obtain the lead in Exports with amount of 13,318 Million AED and contribution of 47.0%, then Base metals and articles of base metals amounted to 6,250 Million AED with contribution of 22.0%, followed by Prepared foodstuffs amounted to 1,955 Million AED with contribution of 6.9%.

The most outstanding sections in Direct Foreign Trade Exports (value in Million)



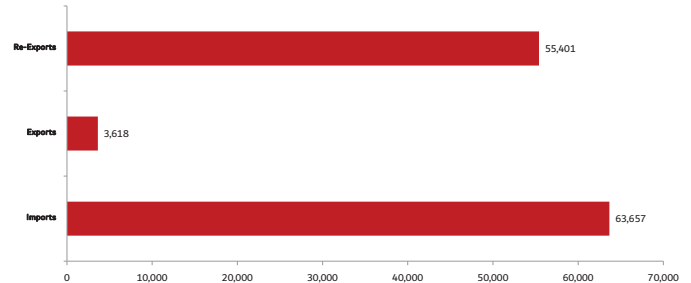
- In Quarter One 2018, Pearls, precious stones and metals obtain the lead in Re-Export with amount of 16,398 Million AED and contribution of 37.0% then Vehicles, aircraft and vessels amounted to 9,461 Million AED with contribution of 21.4%, followed by Machinery, sound recorders, TV and electrical equipment amounted to 9,046 Million AED with contribution of 20.4%.

The most outstanding sections in Direct Foreign Trade Re-Exports (value in Million)



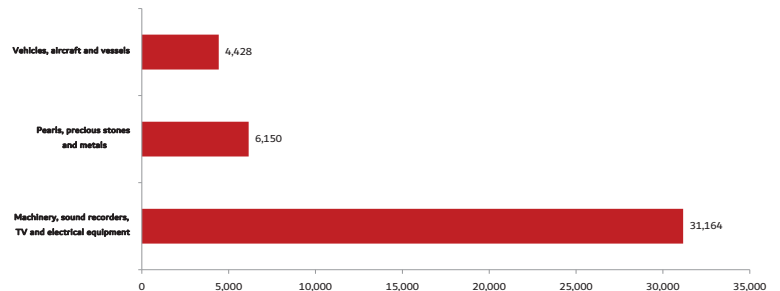
Free Zone Trade

- Imports amounted to 63,657 Million AED and contributed 51.9% of Free Zone Trade In Quarter One 2018.
- Exports amounted to 3,618 Million AED and contributed 2.9% of Free Zone Trade In Quarter One 2018.
- Re-Exports amounted to 55,401 Million AED and contributed 45.2% of Free Zone Trade In Quarter One 2018.



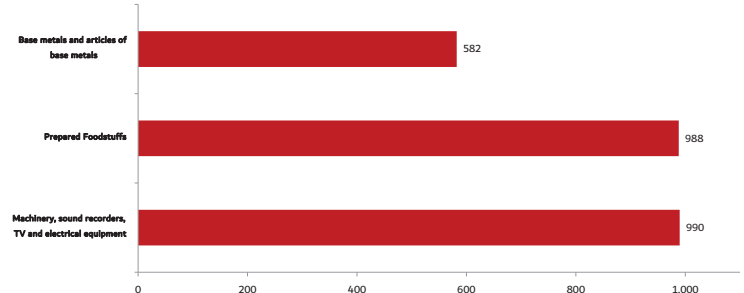
- In Quarter One 2018, Machinery, sound recorders, TV and electrical equipment obtain the lead in Imports of Free Zone Trade with amount of 31,164 Million AED and contribution of 49.0%, then Pearls, precious stones and metals amounted to 6,150 Million AED with contribution of 9.7%, followed by Vehicles, aircraft and vessels amounted to 4,428 Million AED and contribution of 7.0%.

The most outstanding sections in Free Zone Trade Imports (value in Million)



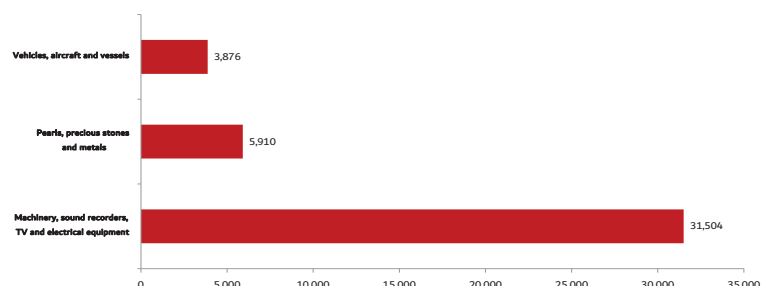
- In Quarter One 2018, Machinery, sound recorders, TV and electrical equipment obtain the lead in Exports of Free Zone Trade with amount of 990 Million AED and contribution of 27.4%, then Prepared foodstuffs amounted to 988 Million AED with contribution of 27.3%, followed by Base metals and articles of base metals amounted to 582 Million AED and contribution of 16.1%.

The most outstanding sections in Free Zone Trade Exports (value in Million)



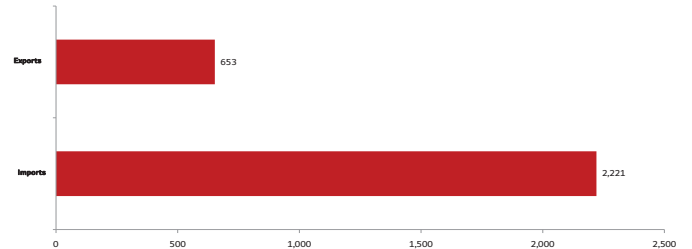
- In Quarter One 2018, Machinery, sound recorders, TV and electrical equipment obtain the lead in Re-Export of Free Zone Trade with amount of 31,504 Million AED and contribution of 56.9%, then Pearls, precious stones and metals amounted to 5,910 Million AED with contribution of 10.7%, followed by Vehicles, aircraft and vessels amounted to 3,876 Million AED and contribution of 7.0%.

The most outstanding sections in Free Zone Trade Re-Exports (value in Million)



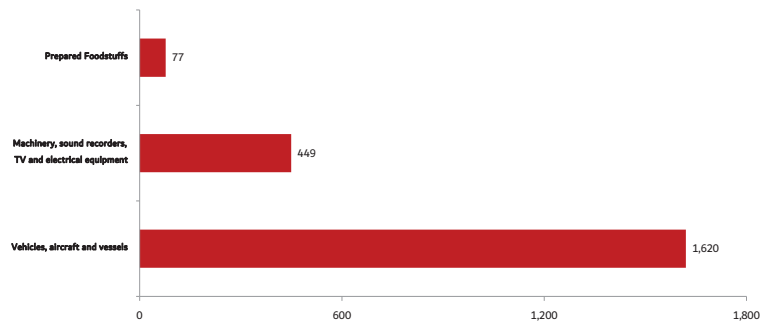
Custom Warehouse Trade

- Imports amounted to 2,221 Million AED and contributed 77.3% of Custom Warehouse Trade In Quarter One 2018.
- Exports amounted to 653 Million AED and contributed 22.7% of Custom Warehouse Trade In Quarter One 2018.



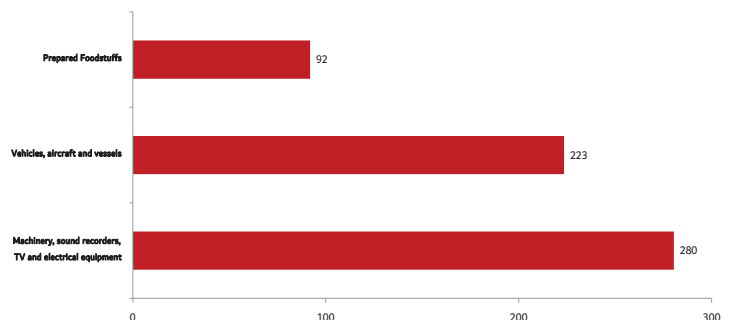
- In Quarter One 2018, Vehicles, aircraft and vessels obtain the lead in Imports of Custom Warehouse Trade with amount of 1,620 Million AED and contribution of 73.0%, then Machinery, sound recorders, TV and electrical equipment amounted to 449 Million AED with contribution of 20.2%, followed by Prepared foodstuffs amounted to 77 Million AED and contribution of 3.5%.

The most outstanding sections in Custom Warehouse Trade Imports (value in Million)



- In Quarter One 2018, Machinery, sound recorders, TV and electrical equipment with amount of 280 Million AED and contribution of 43.0%, then Vehicles, aircraft and vessels amounted to 223 Million AED with contribution of 34.2%, followed Prepared foodstuffs amounted to 92 Million AED and contribution of 14.1%.
