
Index of Industrial Production "Manufacturing Sector"

Third Quarter 2020 - Emirates of Dubai

The index of industrial production for the manufacturing sector for the third quarter of 2020 recorded an increase of 12.37% compared to the second quarter of 2020, and decrease of 1.20% compared to the third quarter of 2019.

| Movement of Industrial Production Index for manufacturing sector during Third Quarter 2020 compared to Second Quarter 2020 (Quarterly change)

The index of industrial production for the manufacturing sector during the third quarter of 2020 recorded an increase of 12.37% compared to the second quarter of 2020. This increment is due to an increase in the production of wearing apparel by 173.52%, refined petroleum products by 51.25%, wood, wood products and cork, except furniture by 50.77%, other manufacturing industries by 38.06%, beverages by 30.03%, furniture by 29.24%, other non-metallic mineral products by 23.17%, basic pharmaceutical products and pharmaceutical preparations by 20.72%, printing and reproduction of recorded media by 18.63%, chemicals and chemical products by 11.47%, machinery and equipment n.e.c by 9.86%, electrical equipment by 9.32%, Fabricated metal products, except machinery and equipment by 4.14% and base metals by 0.92%.





On the other hand, some industries recorded a decrease in their production compared to the second quarter of 2020, as the production of both leather and related products decreased by 39.64%, repair and installation of machines and equipment by 10.33%, rubber and plastics products by 6.81%, tobacco products by 6.48%, motor vehicles, trailers and semi-trailers by 6.27%, paper and paper products by 2.74%, food products by 0.82%.

While other transport equipment and textiles maintained its stability for the third quarter of 2020 compared to second quarter 2020.

Movement of Industrial Production Index for manufacturing sector during third Quarter 2020 compared to third Quarter 2019 (Annual change)

The index of industrial production for the manufacturing sector during the third quarter of 2020-recorded a decrease by 1.20% compared to the third quarter of 2019. This decline is due to a decrease in the production of motor vehicles, trailers and semi-trailers by 34.95%, chemicals and chemical products by 29.19%, other transport equipment by 22.22%, rubber and plastics products by 18.72%, other non-metallic mineral products by 16.94%, machinery and equipment n.e.c by 12.97%, Furniture by 11.42%, textiles by 10.94%, Beverages by 9.34%, printing and reproduction of recorded media by 8.44%, paper and paper products by 7.05%, repair and installation of machinery and equipment by 5.56%, Fabricated metal products, except machinery and equipment by 0.74%.

On the other hand, some industries recorded an increase in their production compared to the third quarter of 2019, as the production of other manufacturing industries increased by 55.45%, leather and related products by 57.90%, basic pharmaceutical products and pharmaceutical preparations by 56.99%, food products by 41.67%, Wood and products of wood and cork, except furniture by 32.41%, Wearing apparel by 28.42%, tobacco products by 8.06%, Base metals by 4.25%, electrical equipment by 3.88% and refined petroleum products by 1.59%.
