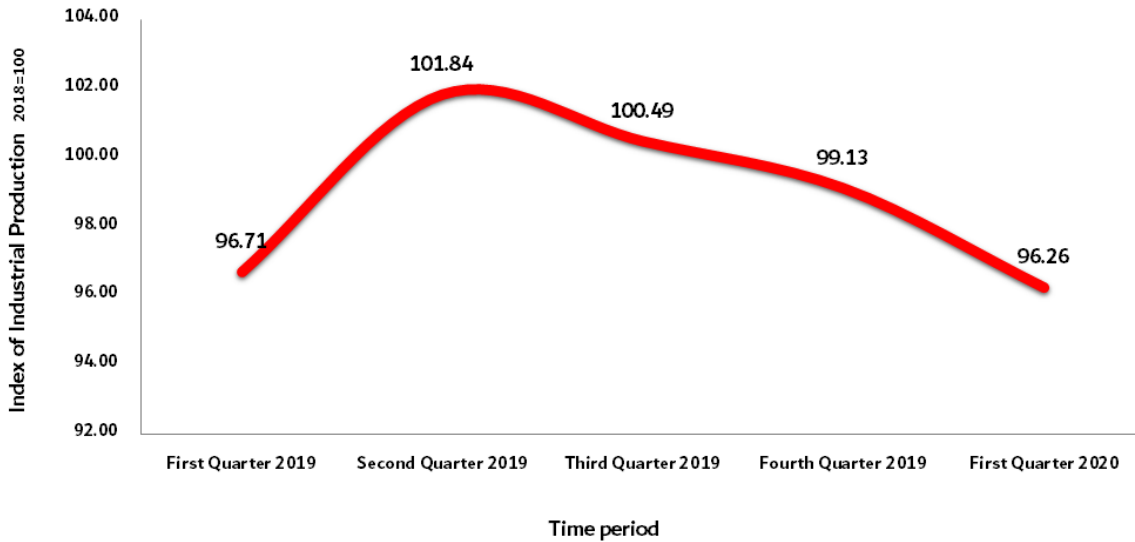
| Index of Industrial Production “Manufacturing Sector”

First Quarter 2020 – Emirates of Dubai

The general index of industrial production for the manufacturing sector for the first quarter of 2020 recorded a decrease of 2.89% compared to the fourth quarter of 2019, and a decrease of 0.47% compared to the first quarter of 2019.

| Movement of Industrial production Index for manufacturing sector during First Quarter 2020 compared to Fourth Quarter 2019 (Quarterly change)

The index of industrial production for the manufacturing sector during the first quarter of 2020 recorded a decrease of 2.89% compared to the fourth quarter of 2019. This decline is due to a decrease in the production of motor vehicles, trailers and semi-trailers Decreased by 29.53%, Tobacco products by 27.46%, Other transport equipment by 22.22%, furniture by 21.41%, Repair and installation of machinery and equipment by 20.03%, Chemicals and chemical products by 17.95%, Wood and products of wood and cork, except furniture by 13.02%, Rubber and plastics products by

11.26%, Beverages by 6.95%, Refined petroleum products by 5.64%, Other manufacturing industries by 5.13%, Machinery and equipment n.e.c. by 3.89%, and other non-metallic mineral products by 2.92%.

On the other hand, some industries recorded an increase in their production compared to the fourth quarter of 2019, as the production of wearing apparel increased by 53.23%, Textiles by 37.35%, Leather and related products By 32.27%, Electrical Equipment by 19.90%, Food products by 16.87%, Papers and paper products by 10.34%, Fabricated metal products, except machinery and equipment by 4.38%, Basic pharmaceutical products and pharmaceutical preparations by 3.87%, Manufacture of basic metals 0.83%, Printing and reproduction of recorded media by 0.13%.

| Movement of Industrial Production Index for manufacturing sector during First Quarter 2020 compared to First Quarter 2019 (Annual change)

The index of industrial production for the manufacturing sector during the first quarter of 2020 recorded a decrease of 0.47% compared to the first quarter of 2019. This decline is due to a decrease in the production of other manufacturing industries by 37.98%, Motor vehicles, trailers and semi-trailers by 20.09%, Leather and related products by 17.94%, Rubber and plastics products by 15.40%, Furniture by 14.31%, Other non-metallic mineral products by 14.09%, Wood and products of wood and cork, except furniture by 7.34% , Tobacco products by 6.80%, Chemicals and chemical products by 5.34%, Fabricated metal products, except machinery and equipment by 3.61% , Manufacture of basic metals by 2.38% and Textiles by 1.01%.

On the other hand, some industries recorded an increase in their production compared to the first quarter of 2019, as the production of Basic pharmaceutical products and pharmaceutical preparations increased by 61.31%, Wearing apparel by 35.09% ,Paper and paper products by 16.06%, Electrical equipment by 15.08%, Printing and reproduction of recorded media by 14.52%, Food products by 12.11%, Beverages by 5.67%, Machinery and equipment n.e.c. by 2.86%, Refined petroleum products by 1.61%, Repair and installation of machinery and equipment by 0.49%.

While other transport equipment maintained its stability for the first quarter of 2020 compared to the corresponding quarter of 2019.
