

#### First Quarter 2020 - Dubai

Producer Price Index for Manufacturing Sector during the First quarter of 2020 decreased by 1.73% compared with the fourth quarter of 2019 and decreased by 2.66% compared with the same quarter in 2019.

# | Producer Price "Manufacturing sector" movement during the First Quarter 2020 compared to the Fourth Quarter 2019 (Quarterly Change)

The Producer Price index of the manufacturing industry decreased by 1.73%, in first Quarter of 2020 Comparing with the prices of fourth Quarter of 2019, this is due to an decrease in Refined petroleum products by 17.67%, Basic pharmaceutical products by 3.83% Motor vehicles, trailers and semi-trailers by 3.52% Machinery and equipment n.e.c. by 2.56% Leather and related products by 2.54%, other non-metallic mineral products by 1.84%, Electrical equipment by 0.80%, Rubber and plastics products by 0.62%, Textiles by 0.30%, Furniture by 0.12% and Wearing apparel by 0.11%.





On the other hand, some industries recorded an increase in their prices compared to the fourth quarter of 2019. Prices of Beverages Increased by 7.78%, other manufacturing by 6.38% and Printing and reproduction of recorded media by 2.77%, food products by 2.31%, Chemicals and chemical products 1.90%, Paper and paper products by 1.72%, Fabricated metal products, except machinery and equipment by 1.67% and Tobacco products by 0.98%.

While Stability observed in prices of Clothing, wood, wood and cork products other than furniture and other transport equipment, compared with a previous period.

## | Producer Price "Manufacturing sector" movement during the First Quarter 2020 compared to the First Quarter 2019 (Annual Change)

The Producer Price index of the manufacturing industry during the first quarter 2020 decreased by 2.66% compared with the first quarter of 2019, This is due to an decrease in Refined petroleum products by 17.61%, Motor vehicles, trailers and semi-trailers by 5.99 %, Basic Metal by 5.18%, Machinery and equipment n.e.c. by 4.56% Leather &Leather products by 3.97%, Paper and paper products by 3.90% Basic pharmaceutical products and pharmaceutical preparations by 3.83%, Textiles by 3.19%, and other non-metallic metal product by 2.15% Rubber & rubber products by 1.86%, beverages by 1.46% electrical Equipment's by 0.72%, furniture by 0.11% and Repair and installation of machinery and equipment by 0.05%.

On the other hand, some industries recorded a rise in their prices during the first quarter 2020 compared to the first quarter of 2019. Prices of Manufacturing by 21.23%, Food products by 2.45%, Fabricated metal products, except machinery and equipment by 2.05%, chemical and chemical products by 1.59%, Printing and reproduction of recorded media by 0.96%, Tobacco products by 0.43%, wood, wood and cork products other than furniture 0.02%.

While Stability observed in prices of clothing and other transport, equipment remained stable for the first quarter of 2020 compared to the corresponding quarter of 2019.
