


#### | Producer Price Index "Manufacturing Sector"

Second Quarter 2020 - Dubai

Producer Price Index for Manufacturing Sector during the Second quarter of 2020 decreased by 5.86% compared with the first quarter of 2020 and decreased by 8.23% compared with the second quarter in 2019.

# |Producer Price "Manufacturing sector" movement during the Second Quarter 2020 compared to the First Quarter 2020 (Quarterly Change)

The Producer Price index of the manufacturing industry decreased by 5.86% in second Quarter of 2020 Comparing with the prices of first Quarter of 2020, this is due to a decrease in Refined petroleum products by 41.72%, Manufacture of basic metals by 10.46%, Rubber and plastics products by 3.70%, Fabricated metal products, except machinery and equipment by 2.28%, Leather and related products by 1.16%, Machinery and equipment n.e.c. by 0.65%, Motor vehicles, trailers and semi-trailers by 0.64%, Tobacco products by 0.61%, food products by 0.35%, Other non-metallic mineral products by 0.13%, and Furniture by 0.11%.





On the other hand, some industries recorded an increase in their prices compared to the first quarter of 2020. Prices of other manufacturing increased by 7.52%, Printing and reproduction of recorded media by 6.95%, Chemicals and chemical products by 3.82%, Paper and paper products by 3.08%, Beverages by 0.82%, Textiles by 0.42%, and Electrical equipment by 0.05%.

While Stability observed in prices of Wearing apparel, Wood and products of wood and cork except furniture, Basic pharmaceutical products and pharmaceutical preparations, other transport equipment, and Repair and installation of machinery and equipment.

## |Producer Price "Manufacturing sector" movement during the Second Quarter 2020 compared to the Second Quarter 2019 (Annual Change)

The Producer Price index of the manufacturing industry during the second quarter 2020 decreased by 8.23% compared with the second quarter of 2019, this is due to an decrease in Refined petroleum products by 54.83%, Manufacture of basic metals by 15.04%, Motor vehicles, trailers and semi-trailers by 5.95 %, Leather &Leather products by 5.09%, Machinery and equipment n.e.c. by 5.06%, Rubber & rubber products by 4.49%, Basic pharmaceutical products and pharmaceutical preparations by 3.83%, Textiles by 1.63%, other non-metallic metal product by 0.90%, electrical Equipment's by 0.75%, and furniture by 0.53%.

On the other hand, some industries recorded an increase in their prices during the second quarter 2020 compared to the second quarter of 2019. Prices of Other manufacturing increased by 29.71%, Printing and reproduction of recorded media increased by 13.79%, chemical and chemical products by 6.86%, Fabricated metal products, except machinery and equipment by 4.25%, Food products by 2.82%, Paper and paper products by 1.10%, beverages by 0.36%, and Tobacco products by 0.15%.

While Stability observed in prices of Wearing apparel, Wood and products of wood and cork, except furniture, other transport equipment, Repair and installation of machinery and equipment in second quarter of 2020 compared to second quarter of 2019.
