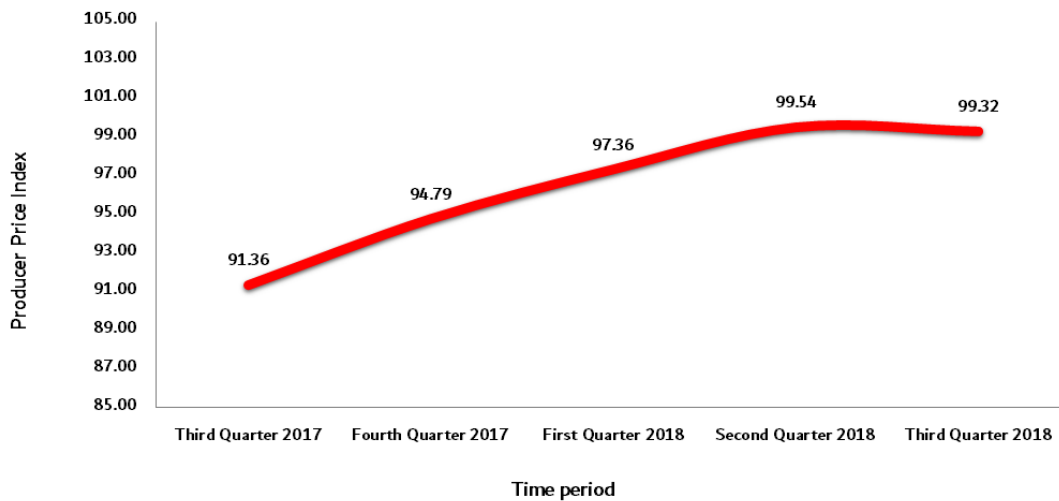


Producer Price Index "Manufacturing Sector"

Third Quarter 2018

Producer Price Index for Manufacturing Sector during the Third Quarter of 2018 decreased by 0.21% compared with the Second Quarter of 2018 while increased by 8.72% compared with the Third Quarter of 2017.

The Producer Price index of the manufacturing industry decreased by 0.21% compared with the Second quarter of 2018, this is due to a decrease in basic metals by 8.18%, Beverages by 1.38%, other manufacturing by 1.19%, Leather and related products by 1.14%, Printing and reproduction of recorded media by 1.11%, Food products by 0.83%, Repair and installation of machinery and equipment 0.54%, Paper and paper products by 0.51%, Wood and products of wood and cork, except furniture by 0.23%, Machinery and equipment n.e.c. by 0.18%.

On the other hand, some industries recorded an increase in their prices compared to the Second Quarter of 2018. Prices of Refined petroleum products by 4.39%, Furniture by 0.72%, Computers, electronic and optical products by 0.69%, Chemicals and chemical products by 0.48% , Rubber and plastics products by 0.31%, Electrical equipment by 0.29%, Motor vehicles, trailers and semi-trailers by 0.27%, Tobacco products decreased

by 0.23%, fabricated metal products except machinery and equipment by 0.01%, Other non-metallic mineral products by 0.01%.

While Stability observed in prices of basic pharmaceutical products and pharmaceutical preparations, textiles and Wearing apparel, compared with a previous period.

| Producer Price "Manufacturing sector" movement during the Third Quarter 2018 compared to The Third Quarter 2017 (Annual Change)

The Producer Price index of the manufacturing industry during the Third Quarter 2018 increased by 8.72% compared with the Third quarter of 2017, this is due to an increase in Refined petroleum products by 39.63%, Basic metals by 7.90%, Other manufacturing by 5.25%, Electrical equipment by 4.91%, Tobacco products by 3.52%, Other non-metallic mineral products by 3.26%, Rubber and plastics products by 2.24%, Chemicals and chemical products by 2.06%, Printing and reproduction of recorded media by 2.00%, Wood and products of wood and cork, except furniture by 1.86% , Leather and related products by 1.76%, Machinery and equipment n.e.c. by 1.58%, Furniture by 1.27%, Beverages by 1.03%, Motor vehicles, trailers and semi-trailers by 0.93 %.

On the other hand, some industries recorded a decrease in their prices during the Third quarter 2018 compared to the Third quarter of 2017. Prices of Food products by 3.22%, Repair and installation of machinery and equipment by 2.71%, Paper and paper products by 1.55%, Fabricated metal products, except machinery and equipment by 0.83%, Computers, electronic and optical products by 0.37%.

While Stability observed in prices of basic pharmaceutical products and pharmaceutical preparations, Textiles and Wearing apparel during Third quarter, 2018 compared with the Third quarter 2017.
