


#### | Producer Price Index "Manufacturing Sector"

Third Quarter 2020 - Dubai

Producer Price Index for Manufacturing Sector during the Third quarter of 2020 increased by 3.33% compared with the Second quarter of 2020 while decreased by 4.34% compared with the Third quarter in 2019.

# |Producer Price "Manufacturing sector" movement during the Third Quarter 2020 compared to the Second Quarter 2020 (Quarterly Change)

The Producer Price index of the manufacturing industry increased by 3.33% in Third Quarter of 2020 comparing with the prices of Second Quarter of 2020, this is due to the increase in the prices of refined petroleum products by 45.13%, other manufacturing by 10.59%, Manufacture of basic metals by 6.15%, Chemicals and chemical products by 1.87%, Printing and reproduction of recorded media by 1.86%, Tobacco products by 0.75%, Motor vehicles, trailers and semi-trailers by 0.64%, Textiles by 0.60%, Electrical equipment by 0.07%.





On the other hand, some industries recorded a decrease in their prices compared to the Second quarter of 2020. Beverages by 6.35%, Rubber and plastics products by 3.42%, Fabricated metal products, except machinery and equipment by 3.23%, food products by 2.76%, Other non-metallic mineral products by 1.69%, Paper and paper products by 0.86%, Leather and related products by 0.47%, Furniture by 0.12%, Machinery and equipment n.e.c. by 0.04%.

While Stability observed in prices of Wearing apparel, Wood and products of wood and cork except furniture, Basic pharmaceutical products and pharmaceutical preparations, other transport equipment, and Repair and installation of machinery and equipment.

## |Producer Price "Manufacturing sector" movement during the Third Quarter 2020 compared to the Third Quarter 2019 (Annual Change)

The Producer Price index of the manufacturing industry during the Third quarter 2020 decreased by 4.34% compared with the Third quarter of 2019, this is due to an decrease in Refined petroleum products by 28.11%, Manufacture of basic metals by 8.18%, Rubber & rubber products by 6.75%, Leather &Leather products by 5.54%, Fabricated metal products, except machinery and equipment by 3.88%, Basic pharmaceutical products and pharmaceutical preparations by 3.83%, Machinery and equipment n.e.c. by 3.42%, Motor vehicles, trailers and semi-trailers by 3.38 %, other non-metallic metal product by 2.44%, Textiles by 0.88%, electrical Equipment's by 0.68%, Food products by 0.59% and furniture by 0.45%.

On the other hand, some industries recorded an increase in their prices during the Third quarter 2020 compared to the Third quarter of 2019. Prices of Other manufacturing increased by 29.04%, Printing and reproduction of recorded media increased by 12.88%, chemical and chemical products by 7.19%, Paper and paper products by 2.94%, beverages by 1.28%, and Tobacco products by 0.20%.

While Stability observed in prices of Wearing apparel, Wood and products of wood and cork, except furniture, other transport equipment, Repair and installation of machinery and equipment in Third quarter of 2020 compared to Third quarter of 2019.
