


#### |Producer Price Index "Manufacturing Sector"

Second Quarter 2018

Producer Price Index for Manufacturing Sector during the Second quarter of 2018 increased by 2.25% compared with the First quarter of 2018 and increased by 9.45% compared with the Second quarter in 2017.

# | Producer Price "Manufacturing sector" movement during the Second Quarter 2018 compared to the First Quarter 2018 (Quarterly Change)

The Producer Price index of the manufacturing industry increased by 2.25% compared with the first quarter of 2018, This is due to an increase in Refined petroleum products by 9.14%, basic metals by 3.26%, tobacco products decreased by 2.96%, Rubber and plastics products by 2.38%, Computers, electronic and optical products by 2.15%, Other non-metallic mineral products by 2.01%, Printing and reproduction of recorded media by 1.91%, Machinery and equipment n.e.c. by 0.70%, Chemicals and chemical products by 0.37%, Wood and products of wood and cork, except furniture by 0.02%.





On the other hand, some industries recorded a decrease in their prices compared to the first quarter of 2018. Prices of Repair and installation of machinery and equipment 3.52%, Food products by 2.24%, Leather and related products by 1.96%, Beverages by 1.26%, Electrical equipment by 0.75%, fabricated metal products except machinery and equipment by 0.45%, Furniture by 0.35%, Motor vehicles, trailers and semi-trailers by 0.21%, Other manufacturing by 0.21% and Paper and paper products by 0.13%.

While Stability observed in prices of basic pharmaceutical products and pharmaceutical preparations, textiles and Wearing apparel, compared with a previous period.

# | Producer Price "Manufacturing sector" movement during the Second Quarter 2018 compared to the Second Quarter 2017 (Annual Change)

The Producer Price index of the manufacturing industry during the first quarter 2018 increased by 9.45% compared with the Second quarter of 2017, this is due to an increase in Refined petroleum products by 38.08%, Basic metals by 18.05%, Electrical equipment by 8.52%, Other manufacturing by 6.22%, Other non-metallic mineral products by 4.51%, Machinery and equipment n.e.c. by 3.34%, Leather and related products by 2.87%, Rubber and plastics products by 2.29%, Beverages by 1.88%, Tobacco products by 1.77%, Chemicals and chemical products by 1.72%, Motor vehicles, trailers and semi-trailers by 1.13 %, Printing and reproduction of recorded media by 0.77% and Fabricated metal products, except machinery and equipment by 0.68%.

On the other hand, some industries recorded a decrease in their prices during the Second quarter 2018 compared to the Second quarter of 2017. Prices of Food products by 6.56%, Repair and installation of machinery and equipment by 3.89% Computers, electronic and optical products by 1.20%, Paper and paper products by 1.13%, Wearing apparel by 0.73 %, Wood and products of wood and cork, except furniture by 0.54% and Furniture by 0.17%.

While Stability observed in prices of basic pharmaceutical products and pharmaceutical preparations and Textiles during Second quarter, 2018 compared with the Second quarter 2017.
