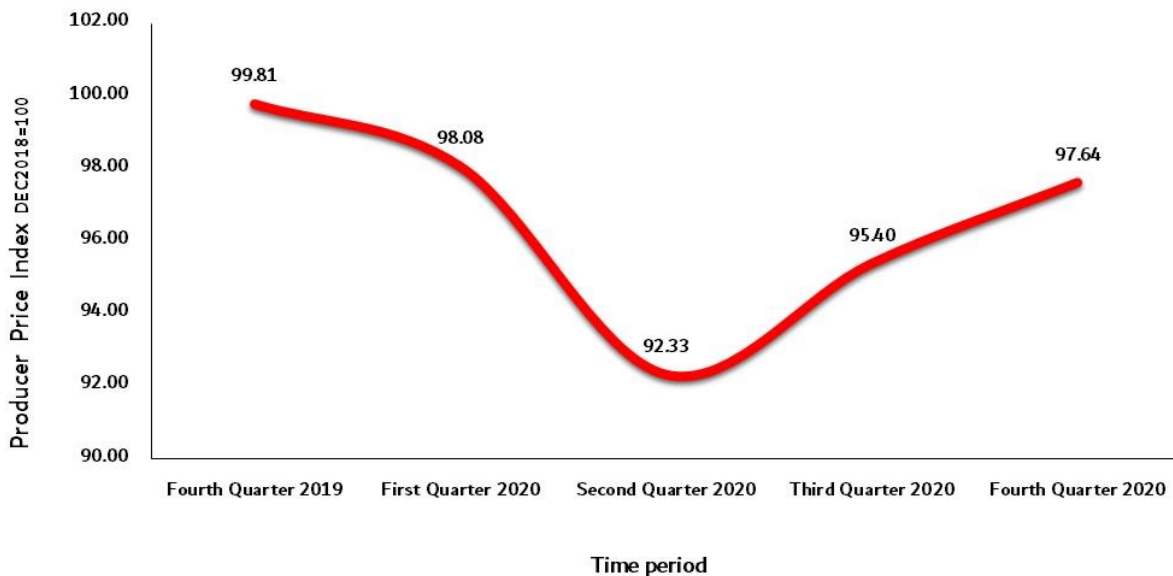
## | Producer Price Index “Manufacturing Sector”

Fourth Quarter 2020 – Dubai

Producer Price Index for Manufacturing Sector during the Fourth quarter of 2020 increased by 2.35% compared with the Third quarter of 2020 while decreased by 2.17% compared with the Fourth quarter in 2019.

## | Producer Price “Manufacturing sector” movement during the Fourth Quarter 2020 compared to the Third Quarter 2020 (Quarterly Change)

The Producer Price index of the manufacturing industry increased by 2.35% in Fourth Quarter of 2020 comparing with the prices of Third Quarter of 2020, this is due to the increase in the prices of refined petroleum products by 9.81%, Manufacture of basic metals by 7.07%, Fabricated metal products, except machinery and equipment by 3.03%, food products by 1.73%, Chemicals and chemical products by 1.57%, Motor vehicles, trailers and semi-trailers by 0.43%, Machinery and equipment n.e.c. by 0.41% Electrical equipment by 0.26%, Furniture by 0.09%, Printing and reproduction of recorded media by 0.01%.

On the other hand, some industries recorded a decrease in their prices compared to the Third quarter of 2020. Rubber and plastics products by 2.25%, Tobacco products by 1.94%, Paper and paper products by 1.85%, other manufacturing by 1.69%, Textiles by 1.69%, Leather and related products by 1.13%, Other non-metallic mineral products by 1.07%, Beverages by 0.63%, Repair and installation of machinery and equipment by 0.55%

While Stability observed in prices of Wearing apparel, Wood and products of wood and cork except furniture, Basic pharmaceutical products and pharmaceutical preparations, other transport equipment.

### **|Producer Price "Manufacturing sector" movement during the Fourth Quarter 2020 compared to the Fourth Quarter 2019 (Annual Change)**

The Producer Price index of the manufacturing industry during the Fourth quarter 2020 decreased by 2.17% compared with the Fourth quarter of 2019, this is due to an decrease in Refined petroleum products by 23.53%, Rubber & rubber products by 9.66%, Leather &Leather products by 5.22%, other non-metallic metal product by 4.66%, Basic pharmaceutical products and pharmaceutical preparations by 3.83%, Motor vehicles, trailers and semi-trailers by 3.11%, Machinery and equipment n.e.c. by 2.83%, Textiles by 0.99%, Fabricated metal products, except machinery and equipment by 0.95%, Tobacco products by 0.85%, Repair and installation of machinery and equipment by 0.55%, electrical Equipment's by 0.42%, and furniture by 0.26%.

On the other hand, some industries recorded an increase in their prices during the Fourth quarter 2020 compared to the Fourth quarter of 2019. Prices of Other manufacturing increased by 24.36%, Printing and reproduction of recorded media increased by 11.97%, chemical and chemical products by 9.47%, Paper and paper products by 2.03%, Manufacture of basic metals by 1.66%, beverages by 1.12%, and Food products by 0.85%.

While Stability observed in prices of Wearing apparel, Wood and products of wood and cork, except furniture, other transport equipment, in Fourth quarter of 2020 compared to Fourth quarter of 2019.
