

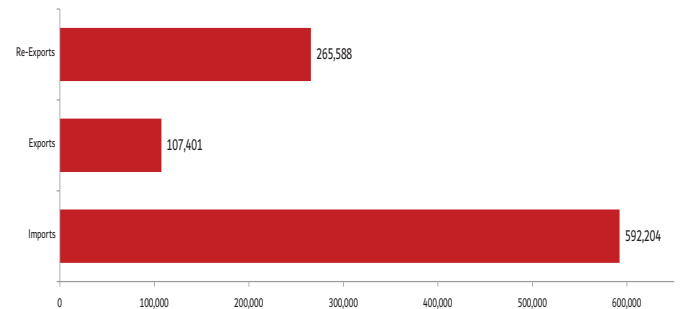

Non-Oil Foreign Trade reaches 965 Billion AED Till Third Quarter 2017

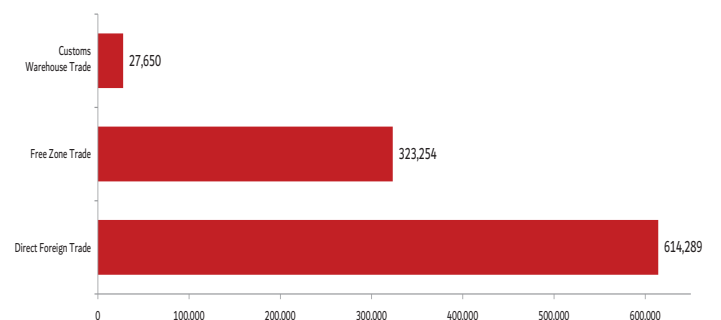
Foreign Trade by Type

- Foreign Trade Imports amounted 592,204 Million AED Till Third Quarter 2017, with contribution of 61.4%.
- Foreign Trade Exports amounted 107,401 Million AED Till Third Quarter 2017, with contribution of 11.1%.
- Foreign Trade Re-Exports amounted 265,588 Million AED Till Third Quarter 2017, with contribution of 27.5%.



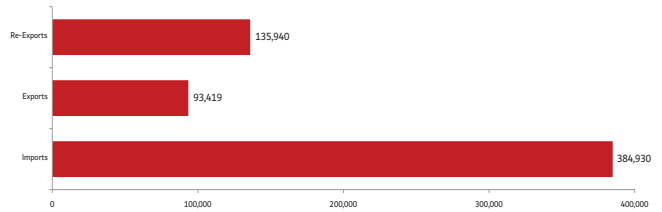
Foreign Trade by Zone

- Direct Foreign Trade amounted 614,289 Million AED Till Third Quarter 2017, with contribution of 63.6%.
- Free Zone Trade amounted 323,254 Million AED Till Third Quarter 2017, with contribution of 33.5%.
- Custom Warehouse Trade amounted 27,650 Million AED Till Third Quarter 2017, with contribution of 2.9%.



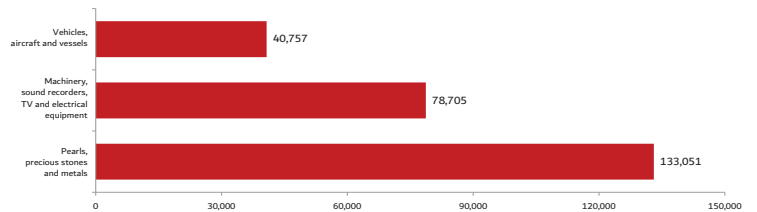
Direct Foreign Trade

- Direct Foreign Trade Imports amounted 384,930 Million AED Till Third Quarter 2017, with contribution of 62.7%.
- Direct Foreign Trade Exports amounted 93,419 Million AED Till Third Quarter 2017, with contribution of 15.2%.
- Direct Foreign Trade Re-Exports amounted 135,940 Million AED Till Third Quarter 2017, with contribution of 22.1%.



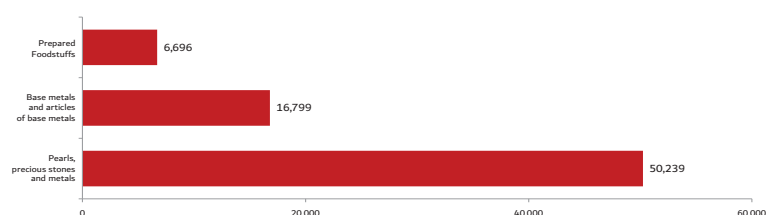
- Till Third Quarter 2017, Pearls, precious stones and metals obtain the lead in Imports with amount of 133,051 Million AED and contribution of 34.6%, then Machinery, sound recorders, TV and electrical equipment amounted to 78,705 Million AED with contribution of 20.4%, followed by Vehicles, aircraft and vessels amounted to 40,757 Million AED with contribution of 10.6%.

The most outstanding sections in Direct Foreign Trade Imports (value in Million)



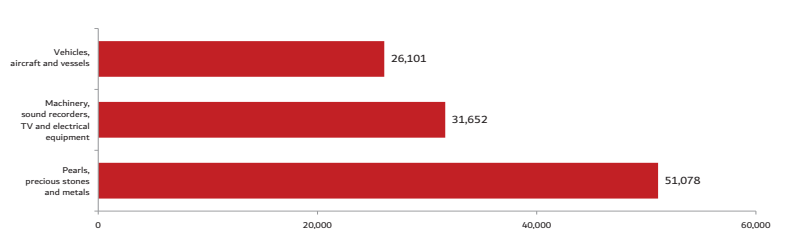
- Till Third Quarter 2017, Pearls, precious stones and metals obtain the lead in Exports with amount of 50,239 Million AED and contribution of 53.8%, then Base metals and articles of base metals amounted to 16,799 Million AED with contribution of 18.0%, followed by Prepared foodstuffs amounted to 6,696 Million AED with contribution of 7.2%.

The most outstanding sections in Direct Foreign Trade Exports (value in Million)



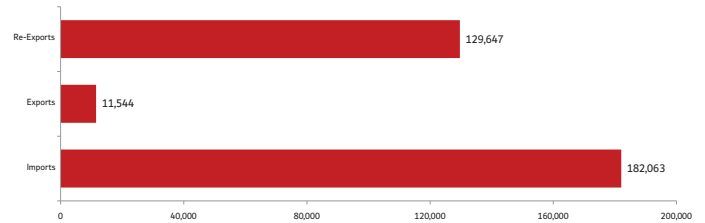
- Till Third Quarter 2017, Pearls, precious stones and metals obtain the lead in Re-Export with amount of 51,078 Million AED and contribution of 37.6%, then Machinery, sound recorders, TV and electrical equipment amounted to 31,652 Million AED with contribution of 23.3%, followed by Vehicles, aircraft and vessels amounted to 26,101 Million AED with contribution of 19.2%.

The most outstanding sections in Direct Foreign Trade Re-Exports (value in Million)

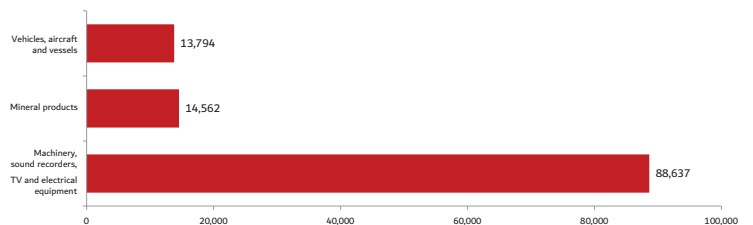


Free Zone Trade

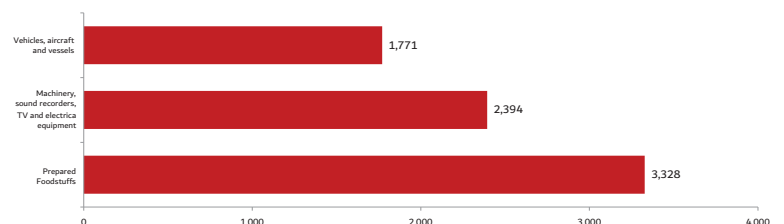
- Imports amounted to 182,063 Million AED and contributed 56.3% of Free Zone Trade Till Third Quarter 2017.
- Exports amounted to 11,544 Million AED and contributed 3.6% of Free Zone Trade in Till Third Quarter 2017.
- Re-Exports amounted to 129,647 Million AED and contributed 40.1% of Free Zone Trade Till Third Quarter 2017.
- Till Third Quarter 2017, Machinery, sound recorders, TV and electrical equipment obtain the lead in Imports of Free Zone Trade with amount of 88,637 Million AED and contribution of 48.7%, then Mineral products amounted to 14,562 Million AED with contribution of 8.0%, followed by Vehicles, aircraft and vessels amounted to 13,794 Million AED and contribution of 7.6%.
- Till Third Quarter 2017, Prepared foodstuffs obtain the lead in Exports of Free Zone Trade with amount of 3,328 Million AED and contribution of 28.8%, then Machinery, sound recorders, TV and electrical equipment amounted to 2,394 Million AED with contribution of 20.7%, followed by Vehicles, aircraft and vessels amounted to 1,771 Million AED and contribution of 15.3%.
- Till Third Quarter 2017, Machinery, sound recorders, TV and electrical equipment obtain the lead in Re-Export of Free Zone Trade with amount of 71,652 Million AED and contribution of 55.3%, then Vehicles, aircraft and vessels amounted to 9,889 Million AED with contribution of 7.6%, followed by Mineral products amounted to 8,977 Million AED and contribution of 6.9%.



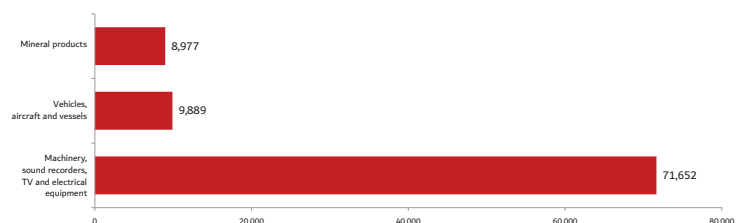
The most outstanding sections in Free Zone Trade Imports (value in Million)

The most outstanding sections in Free Zone Trade Re-Exports (value in Million)

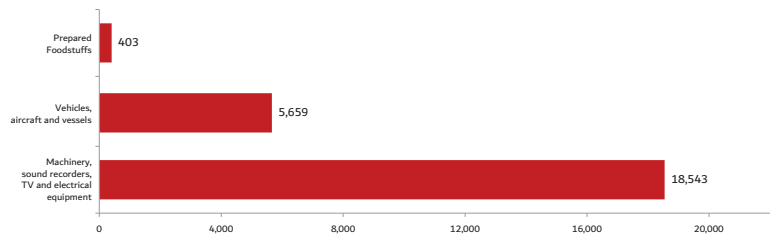


Custom Warehouse Trade

- Imports amounted to 25,211 Million AED and contributed 91.2% of Custom Warehouse Trade Till Third Quarter 2017.
- Exports amounted to 2,439 Million AED and contributed 8.8% of Custom Warehouse Trade Till Third Quarter 2017.
- Till Third Quarter 2017, Machinery, sound recorders, TV and electrical equipment obtain the lead in Imports of Custom Warehouse Trade with amount of 18,543 Million AED and contribution of 73.6%, then Vehicles, aircraft and vessels amounted to 5,659 Million AED with contribution of 22.4%, followed by Prepared foodstuffs amounted to 403 Million AED and contribution of 1.6%.
- Till Third Quarter 2017, Vehicles, aircraft and vessels obtain the lead in Exports of Custom Warehouse Trade with amount of 962 Million AED and contribution of 39.4%, then Machinery, sound recorders, TV and electrical equipment amounted to 900 Million AED with contribution of 36.9%, followed by Prepared foodstuffs amounted to 382 Million AED and contribution of 15.6%.
